**Resignation of Stephen Cornelius** Mayor George called the meeting to order and stated that this meeting was to discuss and possibly accept the resignation of Stephen Cornelius. Cornelius' written resignation states the last day of employment will be September 24, 2019. When posting this job, what step level do the Board members want to pay for a replacement. Kim Kirby informed the Board that the job description had been updated previously by Cornelius. The original called for the superintendent to obtain a Class A license and is now updated to reflect a Class C license.

Alderman Rooney moved to accept the resignation of Stephen Cornelius affective September 24, 2019. Alderman Goentzel seconded and all were in favor.

Alderman Rooney moved to advertise for a replacement in three newspapers (Weston Chronicle, Platte County Citizen, Platte County Landmark) and on indeed.com for employment at a Step Level #4 (\$20.14 per hour) and to state the requirement of two (2) years of supervisory/managerial experience is required. Alderman Goentzel seconded and the motion passed.

Mayor George called the meeting to order and stated that this meeting was to rescind the resignation of Stephen Cornelius.


Alderman Rooney moved to accept rescinding the resignation. James Lowe seconded the motion. All in favor.

Douglas Pump was called to look at the pump and took it with them to repair/rebuild and then reinstall. There was not time to send this out for bid in advance. It would cost the City even more if they were to put it back in, send out bids and then have a company take it back out to repair and reinstall again.

Alderman Rooney motioned to accept the Proposal from Douglas Pump Service, Inc. in the amount of \$9,957.50. Alderman Priddy seconded the motion. All in favor.
